# Clearing House for Postgraduate Courses in Clinical Psychology

#### A year in numbers....

We had 5,161 people apply for the 2023 intake to clinical psychology training: an increase of 7.4% on last year. Of these 4,990 people applied for NHS places and 226 people applied for self-funded places (including 55 people who applied for both types of places).

There were 1,166 NHS places for the 2023 intake. This is another annual increase, though smaller than in recent years: 1% more places than last year. This gives a success rate of 23%.

361 people took advantage of the £10 early-bird discount we offer to those applying by mid-October.

# Completion and employment rates for trainees

At the continued request of the clinical psychology programmes, we provide a central point for collecting data on training completion rates and employment of graduates.

The national non-completion rate for NHS clinical psychology trainees for the academic year 2021/2022 was only 0.7%, which includes all forms of non-completion. This is in line with the rates for the previous 10 years which were between 0.4% and 1.0% each year.

For people completing NHS training in 2022, of those who returned data 96.7% started work as a clinical psychologist (or in an equivalent post) within 12 months of graduating. This is in line with the rates for the previous 9 years which were between 92.0% and 97.0% each year.

Of those working as clinical psychologists (or in an equivalent post) 96.0% were working in the NHS or in other public sector funded posts. Again, this is in line with the rates for the previous 9 years which were between 92.3% and 98.2% each year.

- ⇒ increasing the utility of the pdf download for applicants, so they can see their documents in the same way that programmes see them
- ⇒ making improvements to the pdf download for programmes e.g. providing the option to include/exclude specific questions in the Jobs and Qualifications sections
